3. **ICT Technical Strategy**

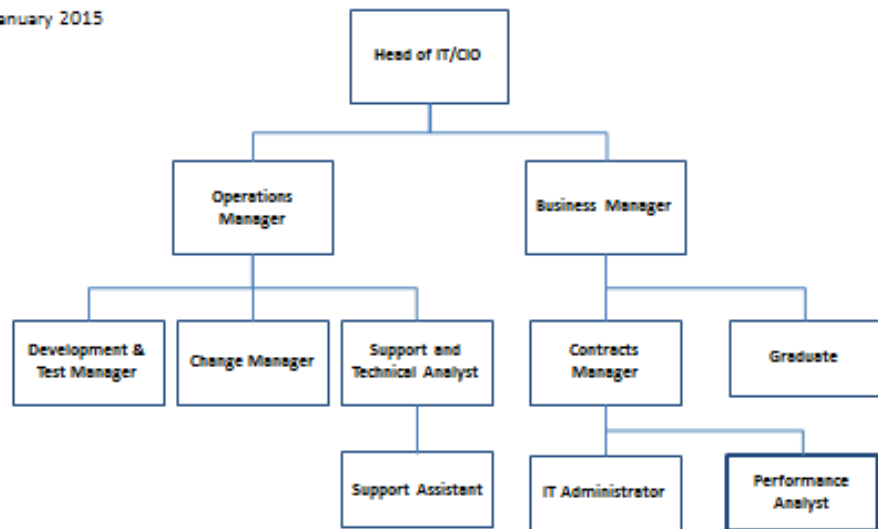
As above, there is no Cafcass technical strategy specific to the IT department.
