Voice of the Child in LFJB's

GUIDE: LFJB's including the Voice of the Child



Children and young people are experts in how they experience the services across your area. Members of the **Family Justice Young People's Board** (FJYPB) have created this guide, with support from members and chairs of Local Family Justice Board's (LFJB's), to help LFJBs include the voices of local children and young people in their work.

Before you begin considering how you want to engage children and young people in your LFJB you need to consider the following:

- Why do you want to include their voices?
- What value will it add to your decision making as an LFJB?
- How will you as an LFJB respond to feedback received from children and young people?

Hearing from children and young people about their experience of services is important but on its own is not enough - you must also be able to respond to what you are hearing, act on and make decisions where these are needed and keep children and young people updated with what you are doing and your progress.

Here are some of the suggestions of how to engage with children and young people:

Children's Complaints



Practice quality standards: child complaint investigations

- 1 Have I met or spoken with the child so that I can understand their complaint and the outcome they're seeking? If I can't speak with the child, have I spoken with their carer/an adult who knows them?
- 2 Have I explained how I will investigate their complaint and the next steps?
- 3 Have I sought to engage effectively with operational colleagues to understand the child's circumstances and identify any strengths or learning?
In the written response
- 4 Have I demonstrated that I understand what is important to the child?
- 5 Have I demonstrated that I understand the child's complaint?
- 6 Have I tailored my communication style to suit the child?
- 7 Have I shared and explained my decision clearly at the start of the letter?
- 8 Is the evidence for that decision explained in a way they will understand?
- 9 Have I clearly explained what we have learned from the child's complaint and how this will be taken forward?
- 10 Is my writing clear and appropriate to the age of the child and their level of understanding?


How long should we have to wait until the practice of sending letters to *a//* children and sharing recommendations is fully embedded into practice?
